We use the information collected through our website to facilitate donation collection and processing, to provide tax receipts, to process memberships and to communicate relevant news and updates. Innocence Canada and Innocence Canada Foundation do not trade, license, rent or sell your personal information in any manner.

Privacy Statement and Summary

Innocence Canada and Innocence Canada Foundation work carefully to ensure that your personal information is kept safe and secure throughout the transaction process and otherwise while in our custody or under our control. Innocence Canada and Innocence Canada Foundation are committed to protecting and safeguarding the privacy and security of the personal information provided to us by our donors and registered charities in compliance with the Personal Information Protection and Electronic Documents Act (Canada) (PIPEDA). By making a donation, requesting information or becoming a member, you are giving Innocence Canada and Innocence Canada Foundation permission to collect some of your personal information and to contact you by way of the information provided for the purposes outlined in this Privacy Policy. This Privacy Policy explains what information we collect and why we collect it, how we use that information, how the confidentiality of this information is protected, and how you can find out what personal information is recorded.

General Privacy Practices

Innocence Canada and Innocence Canada Foundation observe the following privacy practices from its direct-to-donor site where visitors can donate to Innocence Canada Foundation or become an Innocence Canada member:

- Innocence Canada and Innocence Canada Foundation collect information only for specified purposes.
- We require that you provide only the necessary amount of personal information to provide any service, as required by law or by the Canada Revenue Agency (CRA).
- We may ask you for more information about yourself to help us provide you with more personalized information and services, but in such cases, you are not obligated to provide such information.
- Personal information gathered by Innocence Canada and Innocence Canada Foundation is held in the strictest confidence and is protected by industry standard best practices.
- In certain instances, Donors are able to restrict the amount of information shared with the charities they support. In doing so, Innocence Canada and Innocence Canada Foundation may not be able to provide certain services that require personal information. Innocence Canada and Innocence Canada Foundation will inform you of the implications of opting out.

What is Personal Information?

Personal information is defined as any information about an identifiable individual including information that can be used to recognize, identify or contact a specific individual, whether it concerns an email address, where an individual lives, or which interests, causes and organizations he or she supports. Personal information does not include most business contact information such as the name, title, business address, or business telephone or fax number or business email address of an employee of an organization, and certain publicly available information.

Innocence Canada and Innocence Canada Foundation regularly review their privacy practices and update their Privacy Policy as required.
